AFMA Membership and Code of Conduct

AFMA Membership consist of

63 Full members **76** Associate members **15** Affiliate members

Total AFMA Members **154**

As participants in the industry self-regulation initiative, both Full and Associate members of AFMA demonstrate their dedication to ensuring the production of safe feed for safe food.

This commitment is validated through the renewal audits, conducted every two years at all AFMA Members' premises, to verify compliance with the AFMA Code of Conduct. The obligation to adhere to the industry code is explicitly outlined in the AFMA Memorandum of Incorporation (MOI).

Since January 2022, the following updates regarding the membership status of the Code of Conduct have been documented:

- → 92 renewal applications have been received.
- 120 facility audits were completed.
- 102 certificates of compliance with the Code of Conduct were issued.
- → 54 new membership applications were submitted.

Compliance issues identified during the audits were as follows:

- → Loss of continuity due to personnel changes resulted in 21.1% of non-conformances reported.
- → Labelling not compliant with approved labels.
- Legal entity not compliant with section 7(1)(a) it is registered under this Act under the name or mark under which it is so sold.
- PPE not in use.
- Section 9 invoicing not included in bulk delivery documentation.

The above compliance matters highlight areas that require attention and corrective actions to ensure adherence to established standards and regulations.

Individuals who are employed by an AFMA member company and have expertise in feed manufacturing, animal nutrition, feed analysis, or quality control, have an opportunity to join the AFMA Technical Committee (TC). Members of this committee can actively contribute towards various strategic projects of AFMA through participation in a TC Sub-Committee.

The TC strategic projects focus on feed safety, ingredient quality, feed analysis and nutritional standards. These are further diversified into specific project outcomes relating to (1) the monitoring of undesirable substances such as salmonella, mycotoxins, and dioxins, (2) medicated feed and antimicrobial resistance, (3) ingredient quality and specifications of known and/or novel feed ingredients i.e., sulphur, and (4) the revision of nutrient specifications of all types of farm feed.

Eligibility to participate – All employees of AFMA member companies can join, provided you are committed to the Technical Committee's objectives, possess the relevant experience and knowledge to contribute, and can commit themselves for the duration of the project(s).

Your role as a committee member provides you with an opportunity to:

- assess, evaluate, or update industry guidelines to keep information relevant.
- compile new guidelines for improved feed safety and communication with the industry and assess feed contaminant data for risk management.
- provide input and comment on feed safety and regulatory matters regarding animal feed, ingredients, and manufacturing.
- vote for the adoption of new and/or updated AFMA technical guidelines etc.

The National Freight Logistics Roadmap – an update

The webinar held on December 12, 2023, provided a comprehensive update on the National Freight Logistics Roadmap, with a particular focus on Transnet's efforts to enhance operational performance and collaboration within the freight industry. Rudi Dicks, Head of The Presidency's project management office, emphasised understanding the challenges faced in the logistics sector, particularly in corridor recovery teams (CRTs). He praised recent collaborative efforts in the action labs addressing issues like iron ore, coal, and container terminals. He also emphasised the need to adapt procurement regulations to suit Transnet entities' commercial nature.

Key points highlighted during the webinar include:

- Immediate Action Plans Businesses are committing resources to address immediate challenges, leading to the development of clear three-month plans.
- Government Support The Minister in the Presidency has adopted the Freight Logistics Roadmap (FLR), outlining short, medium, and long-term strategies for addressing logistics challenges.
- Stakeholder Collaboration Structured stakeholder collaborations are being established to improve Transnet's performance. The Transnet Board and stakeholders, through Operational Excellence Centres (OECs), are closely monitoring the path to business recovery.
- Necessity for Support The necessity for both government and private sector support has been carefully defined to address comprehensive operational challenges and promote sustainable growth.

Mr Mxolisi Mgojo, CEO representative on the National Logistics Crisis Committee (NLCC), endorsed the collaborative efforts and emphasised the collective responsibility to support Transnet for the country's sustainability and competitiveness in global markets.

Transnet's Group Executive, Michelle Phillips, along with her team, highlighted Transnet's recovery plan involving collaboration with customers, stakeholders, and experts. The plan includes initiatives to enhance financial stability, cost-saving measures, and a high-performance culture. Infrastructure improvements, equipment reliability, and protection of rail networks from vandalism and sabotage were also discussed.

The Key focus areas for Transnet include:

- Infrastructure Improvements Plans to improve operating efficiency at port terminals and rectify past mistakes.
- Financial Viability Prompt payment from customers to enhance financial stability.
- Procurement Adaptations Changes to procurement regulations to suit the commercial nature of transit entities.
- Digital Transformation Initiatives to reduce manual processes and human errors, prioritising safety and efficiency.

The last section of the webinar involved participants offering comments and questions, highlighting overwhelming support for Transnet's initiatives and plans for recovery. Participants emphasised the importance of engagement with stakeholders across different sectors and raised questions regarding procurement processes and equipment acquisition.

In closing, speakers expressed gratitude for participant engagement and support, acknowledging the complexity of challenges but remaining optimistic about overcoming them through collaborative efforts and continuous improvement. Overall, the webinar underscored the importance of protecting Transnet's network, improving operational efficiency, and fostering collaboration to enhance the national freight logistics system.

Computing purpose and progress of established oilcake import duties

Several years ago, South Africa heavily depended on imported oilcake from Argentina due to limited local production. In 2000, a tariff system was implemented for oilcakes to protect and boost the domestic agricultural sector, fostering the growth of local production and the expansion of crushing capabilities.

Since then, the scenario has transformed, with South Africa consistently producing over 2 million tons of soybeans annually and trading at export parity prices. The export parity price, serving as a baseline, signifies that locally produced soybeans can compete globally, indicating a surplus in the local market.

Additionally, crushing capacity has increased, considering that local soya oilcake is traded based on import parity calculations. Notably, the tariff has successfully achieved its goal of developing the local soybean industry, as evident from South Africa now trading at export parity for soya beans and import parity for oilcake.

This forms the basis for AFMA
Trade Committee's request to
reassess the current tariff structure for
oilcake to ensure fair trade practices
that will benefit all participants in
the value chain. AFMA will continue
to liaise with the soya value chain
stakeholders on this matter and
advocate for the reduction of the
import duty for soya oilcake.

Laboratory Sub-Committee explores new project proposal

In October 2023, the Laboratory Sub-Committee evaluated a new project proposal aimed at standardising feed analysis methods. Whilst the proposal was not immediately adopted by the TC Exco as a strategic project due to certain shortcomings, the committee acknowledged its educational value for AFMA members.

Subsequently, they proposed that the outcome be redefined as an awareness project that will inform all members of various factors to consider when assessing laboratory analysis reports and requesting specific analysis from a feed laboratory.

The committee endeavours to publish an article in the AFMA Matrix in this regard, which underscores the committee's commitment to address industry challenges and facilitate the transfer of knowledge.

The National One Health Forum Webinar: A Comprehensive Discussion on One Health in South Africa

On 19 January 2024, the National One Health Forum and Future Africa, at the University of Pretoria, jointly hosted a pivotal webinar addressing the state of One Health in South Africa.

The event brought together experts and stakeholders from diverse sectors, highlighting the crucial integration of human, animal, and environmental health for optimal health outcomes.

The discussion underscored the importance of a multi-sectoral approach to address One Health challenges, emphasising the necessity for robust governance and adequate resources for successful strategy implementation. The webinar delved into the global significance of One Health, its application in Africa, and its specific implementation in South Africa. Notably, the effective response to avian influenza in the Western Cape exemplified collaborative efforts across various health sectors.

Challenges such as farm access for human surveillance and the impact on community mental health were explored, emphasising the ongoing need for multi-sectoral collaboration, education, and communication. The webinar concluded with a call for heightened awareness and preparedness

for zoonotic diseases, particularly avian influenza, recognising its potential impact on human health.

This event underscored the imperative of a comprehensive One Health approach in addressing health challenges, emphasising the critical role of continuous collaboration and communication among stakeholders. Such an approach is vital to safeguard the health of humans, animals, and the environment and to prevent health crises.

This webinar serves as a prelude to the 8th World One Health Congress scheduled from 20-23 September 2024. Organised by the global One Health Community, the Congress will facilitate insightful discussions on One Health science, antimicrobial agents and resistance, and the science-policy interface.

PARSON TO THE WAR AND THE WAR

Update on the Sulphur Project

A request to address safety issues with feed-grade sulphur initially sparked interest, with a dedicated Sub-Committee formed to define the project's objectives and potential outcomes. Understanding the need for detailed data to make an informed decision, the committee agreed that an initial survey was essential.

This survey was designed to gather information on the quantity and source(s) of sulphur utilised in the animal feed industry and to assess any associated risks. This vital step was necessary to decide if the project should be pursued actively by the Technical Committee.

Despite the importance of this initiative, the response rate to the initial survey was disappointingly low. Only 25% of feed manufacturers and 22% of premix producers participated.

To gather more extensive data, a follow-up survey was issued in November. This second survey reached out to the same feed mills and premix manufacturers and additionally extended to ingredient suppliers.

Following this effort, the Sulphur Sub-Committee reconvened at the end of November to reassess the project's viability and strategic relevance based on the latest input. After careful consideration, the Sulphur SC concluded that AFMA should not actively pursue changing current standards or legislation regarding feed-grade sulphur use.

Instead, the consensus was to shift the focus towards improving awareness of the safe handling of potentially hazardous materials, including sulphur. This initiative will be conducted through the AFMA matrix, aiming to enhance safety practices within the industry.

The way forward for gene-edited products

A major upset was caused in the agricultural value chain in August last year when the Minister of Agriculture decided to overrule an Appeal board recommendation, which resulted in gene-edited products being regulated under the existing risk assessment framework for genetically modified organisms (GMOs) under the GMO Act.

This decision by South Africa on products derived from gene-editing / new breeding techniques (NBT's) could impede agricultural innovation and investments and undermine efforts to improve productivity and food security. It may also impact the trade of agricultural products and act as a new barrier to trade in emergencies.

The severity of the potential impact of this decision on South African agriculture necessitates a collective approach of all stakeholders. AGBIZ is hosting a **workshop** on **26 February** that will address the current regulation of products generated through gene-editing techniques and the potential implications on cultivar development and associated trade constraints within the agricultural value chain.
